Shelter Care provides Rapid Rehousing rent and supportive services to homeless families in Winnebago and Boone Counties in IL. Families receive rent assistance for up to two years, with a focus on helping each family gain financial stability within 12 months so they can pay their full rent. Families who are unable to increase cash income to a level necessary to afford market rent are referred to the local Public Housing Authorities to obtain subsidized housing. Families receive intensive case management, in general once per week, especially towards the beginning of their entry into the project. This can decrease to once per month once the family is financially stable and does not have intense service needs.
